- 1) CE/ISO certification fees (\$1,200-\$2,800)
- 2) Sea freight insurance (1.5%-3% of FOB value)

Demand 360? factory walkthrough videos - real workshops don't hide welding stations

Test payment terms: Reputable suppliers offer 30% deposit, 70% after QC inspection

Policy Alert: China's VAT Rebate Window Closes Dec 2024

The 13% export tax rebate for heavy machinery expires in 6 months. A Shanghai-based exporter confirmed: "Buyers completing contracts before November 30 could save \$5,070 on a \$39,000 rig."

With global infrastructure spending projected to hit \$9.1 trillion by 2025, locking in cost-effective core drilling equipment from China becomes mission-critical. Start comparing supplier quotations this week - lead times average 45-60 days for customized orders. Remember: The best deals go to those who negotiate during China's Q4 production surge (September-December).
